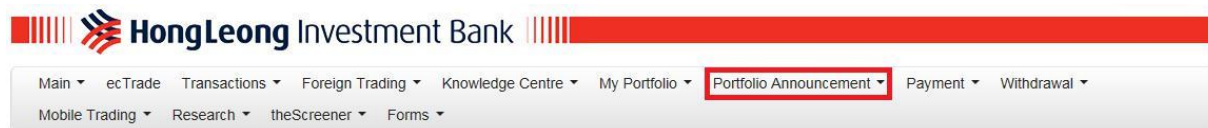


Portfolio Announcement

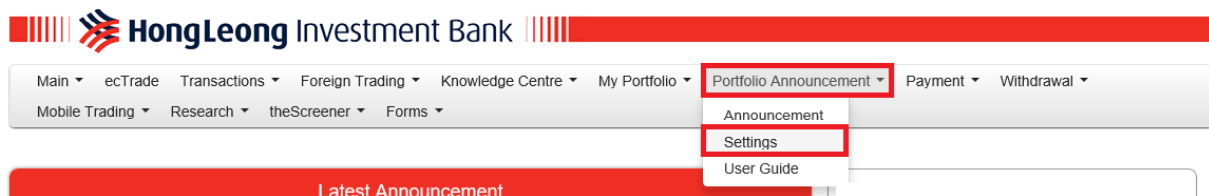

Email Notifications

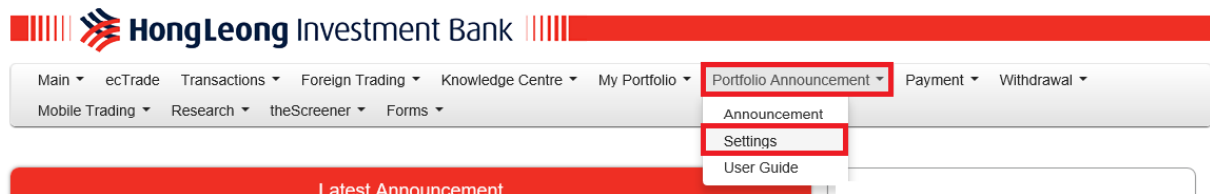

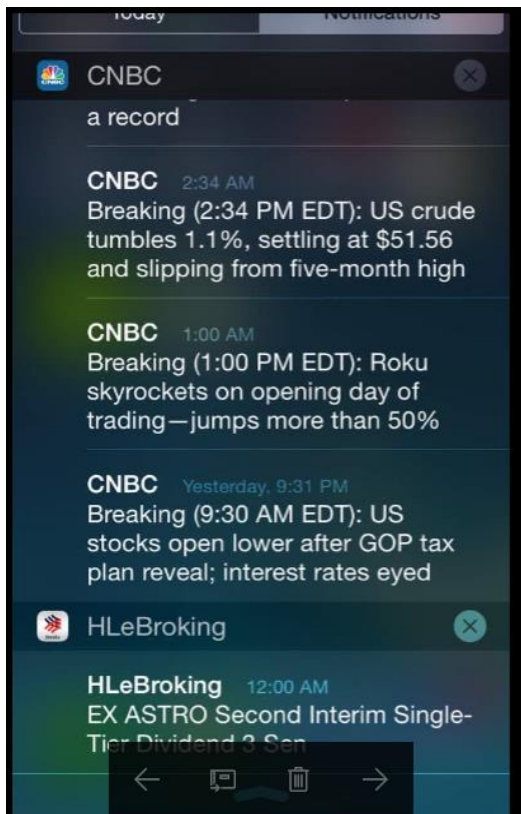
