

## Terms and Conditions for Ayers Mobile App Rewards

### 1. Promotion Period

- 1.1 This Hong Leong Investment Bank Berhad's ("HLIB") Ayers Mobile App Rewards ("Promotion") will commence from 1 August 2016 – 31 December 2016 (both dates inclusive) ("Promotion Period").

Thereafter, HLIB will credit/rebate USD 5.00 being the difference between the prevailing brokerage rate and the Preferential Brokerage Rate to the Participant's account within seven (7) business days **after** the last trading day of the month. .
